#### Dear readers,

It is my pleasure to welcome you to the first issue of the HEROES Newsletter as coordinator of the HEROES Joint Action, the three-year European Commission co-funded Joint Action aimed at improving countries' capacity for health workforce planning to ensure future accessible, sustainable and resilient health systems.

JA HEROES involves 19 European countries that will work to improve their health workforce planning capacity through a process of mutual learning and exchange of good practice. To make this process more effective, the countries have been divided into three clusters, led by cluster leaders, and will work on four tasks relating to four key dimensions of health workforce planning: the availability of good quality, up-to-date data; the use of reliable forecasting models; the dissemination of planning skills to the different levels of decision-making; and the broad involvement of stakeholders.

These four areas are not only interrelated, but also interlinked with other areas of the workforce planning system that will be addressed during the project: the levers used to regulate the health labour market; organisation and actors in the decision-making process; regulation of health

workforce practice; implementation and accountability of health workforce policies; existing strategies, etc.

In the HEROES Newsletter you will find information on the main progress being made in the countries participating in the project (in this issue Italy, Romania and Sweden), contributions from experts (in this issue Prof. Gilles Dussault) and the views of the main stakeholders (in this issue the European Federation of Nurses Associations and the Standing Committee of European Doctors), as well as information on the main events and initiatives related to the HEROES project.

The meeting of the European Network of Medical Competent Authorities (ENMCA) was hosted by the Medical Chamber of Slovenia in Ljubljana. The conference was attended by 38 representatives of 21 health regulatory authorities from across Europe. 
